steelton pa ±17111 detective rupert odrdered me to complain against the neighbors after a baby was born on a mattress inside their house.rupert drove me to the neighborhood after the 911 operator sent me to the station. two police were on my porch beating down my door, rupert let me out of the back of his car and yelled at me to shut up and settle down, after heordered me to complain. the thre police yelled at me not to say anything i couldnt prove in court. rupert wient back to the station and filed a report he later denied in court under oath. i went to every agency in the state capitol, but no one would do anything, every elected official was talking about the problem but noone would let me file a complaint or investigate or anything.two years of complaints reached hbg pa and no one ever looked into this mess. thaT IS THE SWORN TESTIMONY OF MS. BIXLER, IF THAT IS HER REAL NAME. 





As such, benefits must be allowed under Section 402(e).

Bill Would Emphasize Awareness Training for Those Most Likely to Witness Abuse

WASHINGTON, D.C. - U.S. Senator Bob Casey (D-PA) today introduced legislation to require all adults to report child abuse and neglect to the appropriate authorities.

"As we're trying to comprehend what appears to be a case of blatant failure on the part of adults to protect children, our focus should be on doing everything we can to prevent abuse in the future," said Senator Casey. "I introduced this legislation to close a loophole that allows abusers to get away with heinous crimes and emphasize the responsibility of all adults to protect children from abuse and neglect."

The Speak Up to Protect Every Abused Kid (Speak Up) Act of 2011 would require all states to pass and enforce a law requiring all adults to report instances of known or suspected child abuse in order for states to receive funding through the Child Abuse Prevention and Treatment Act (CAPTA), the federal statute focused on child abuse and neglect prevention and response.

The Speak Up Act will specify that child abuse must be reported directly to law enforcement or the state's Child Protective Services agency. Currently, federal law does not specify to whom mandated reporters must report suspected abuse or neglect. In Pennsylvania and many other states, the reporter must notify only the person in charge of the relevant institution, creating a loophole that tragically prevents or delays action against suspected abusers.

The bill will also:

- Provide support to states to carry out educational campaigns and training to inform individuals about what constitutes child abuse and neglect, and promote greater responsibility;
- Promotes new approaches and techniques to improve reporting; and

# Sen. Leach: Human trafficking is in your own back yard

Believe it or not, Upper Merion is a hotbed for human trafficking and Pennsylvania is a major hub of this illegal trade, State Sen. Daylin Leach, D-17th, of Montgomery and Delaware counties, said during Thursday night's town hall meeting.

Some 100,000 young girls in America are brought into prostitution rings, said Leach, who recently introduced a Senate bill which would require signage at businesses alerting people of a special human trafficking relief hotline.

"It's modern-day slavery," he told Plymouth residents.

"Some are foreign nationals who are told they have a debt to pay and that they have to work it off. The average age at which this occurs is 13 years old. It's a horrible situation."

According to Leach, human trafficking is most common at restaurants, hotels, strip clubs, massage parlors and nail salons. An 8"x11" sign would advertise a hotline number to call and impose duties on prothonotaries.

"It's free, it's confidential and it's not run by the government, so people will get the help they need," said Leach.

"Whether you are a victim, or you know a victim, if someone works at a facility where (human trafficking) happens, they will see that sign every day."

The senator named Toledo, Ohio, as the No. 1 area of reported human trafficking incidents, with Pennsylvania among the top four states in the country having it. But human trafficking is not a pandemic restricted to immigrants. In some cases, American young women, most often runaways, fall subject to this crime.

While Leach said he thought his legislation would be a "no-brainer" to pass, he gave the name of one member of the General Assembly who opposed it. John Gordener, R-27th Dist., of Columbia, Montour and Snyder counties, could not be reached for comment at press time.

In other news, Leach, who said he worked at his Senate job on an average of 80 hours a week, warned of the repercussions of Thursday morning's Commonwealth Court decision regarding MCare funds. In an effort to resolve the state's longstanding budget dilemma, the General Assembly transferred millions of dollars from MCare fund. The court ruled, 4-1, to return those funds.

"The court said the money transferred from the MCare fund to the general fund was transferred illegally," Leach told The Times Herald.

"The governor said he would appeal this decision, but if it does stand, it makes it much more difficult to pass a balanced budget. We had a \$700 million hold, and now it more than doubles what our problem was."

Julie\* was walking down the street when a man in a car pulled up to talk to her and convinced her to take a ride. She explains,

I really didn't want to 'cause I was scared but you know how an older person just comes at you like that and you don't know what to do...He just said we were going to just sit there for a minute and you know a minute turned into days. He was acting all nice and buying me whatever I wanted.

At the time she was approached by a trafficker, her home life was chaotic. She lived in poverty with an alcoholic father. When he became intoxicated, yelling would quickly progress to physical assaults. She felt stuck.

I did want to leave...because my dad, he's always drinking and stuff like that and till this day now, he still does it and back then he would slap me and stuff so I didn't want to stay, you know, but I didn't want to leave cause that lifestyle, at first I thought it was ok but after being out there and having to do that...

At the time of her recruitment Julie was barely connected to school, with special needs and not receiving sufficient grades, she continued to attend in hopes of catching up with her classmates. Over time, and with much convincing from her would be trafficker, Julie ended up hesitantly agreeing to get in the car. Over time he convinced her to be driven to Harrisburg, PA. While there she was taken to a motel to dress in sexier clothing and driven to a truck stop and was expected to sell herself. She was walked over to various trucks, forced to get in and have sex with truck drivers while her "waited."

[He took me] to where all the other girls are, 'cause he got like five other girls and we was at a motel. We stayed until it got dark like around five or six then went out there and worked. I didn't know it was going to be a truck stop, I didn't know what to think. I didn't think I would have to walk up and down in the cold and having nasty old truck drivers touch me and stuff. I didn't feel right...I gave the girl the money; the girl held my money after every date I had.

At the end of three days, and with the help of a truck driver and an adult friend, also recruited from Toledo into the sex trade, they were able to escape and call the police.

With the help of the Innocence Lost Task Force, she was rescued and the traffickers were prosecuted.

However, rescue out of the sex trafficking is not the end of the story, but the beginning of a longer, more difficult road to recovery. After returning to school, Julie was ridiculed by her classmates for being a "prostitute". As a result, she refused to attend school, quickly fell behind, and quit. Although child protective services were involved, the

Musser was convicted in March of charges including aggravated indecent assault, unlawful contact with a minor and corruption of minors.

Investigators said he molested one girl multiple times starting in 2008 when she was 9. Another girl also accused him of fondling her during a boat ride in Penn's Cave in Centre County in 2002 when she was 12 or 13.

Musser denied committing the crimes. At trial, Morris claimed that the girls lied about being molested. There was a lack of other evidence to corroborate their claims, he said.

The state attorney general's office prosecuted Musser to avoid any appearance of a conflict of interest by the county district attorney's office. Musser's son, Michael Musser Jr., who has been involved in Steelton Borough government, contributed to the political campaigns of District Attorney Edward M. Marsico Jr.

At today's hearing, Deputy Attorney General Christopher J. Jones called Musser's accusers "brave young girls

"It's not easy to relive this nightmare," Jones said. "What these young girls are still going through is terrible. I can see it in their eyes.

"This is something that's going to have an impact on them potentially for the rest of their lives," he said.

Both girls were "exploited" by Musser, Jones said, adding that "Clearly this case calls for a significant state (prison) sentence."

Musser, who had no prior criminal record, declined a chance to speak during the hearing.

While he sent Musser to prison, Hoover sided with Morris in deciding not to declare Musser to be a sexually violent predator under Megan's Law. Even so, as Morris noted, Musser will have to register with police for life as a sex offender.

Hoover refused when Morris asked that Musser be allowed to remain free on bail pending an appeal. Instead, a sheriff's deputy slapped Musser in handcuffs and led him away.

Dear Mr. Sakmar:

This office has now completed its confidential inquiry of your complaint against. Esquire.

You complained about steps took or did not take in prosecuting you. The conduct you described constitutes a claim of prosecutorial misconduct. Before this office may review the conduct and claim in terms of the ethics rules the court must find that he engaged in prosecutorial misconduct. If the court makes such a finding you may bring it to our attention. We cannot assist you in this regard. As well, in regard to conduct that occurred more than four years ago, Disciplinary Board Rules §85.10 (Stale matters) provides, in pertinent part, that "[t]he Office of Disciplinary Counsel or the Board shall not entertain any complaint arising out of acts or omissions occurring more than four years prior to the date of the complaint."

We do not have a basis to conduct further disciplinary inquiry and have dismissed your complaint. Let me briefly explain the process in which we engage before dismissing a complaint. After reviewing the file and making a determination for the dismissal, I forward the file to another attorney in this office. The second attorney will then review my recommendation and the file and will either concur in or modify my recommendation. In this case the reviewing attorney concurred in my recommendation to dismiss this complaint.

With few exceptions, the attorney disciplinary system is confidential and remains so unless and until formal disciplinary charges are filed by the Office of Disciplinary Counsel

### \$6M push to help Virginia sex trafficking victims

RICHMOND, VA (WWBT) - There's a \$6 million push in the works to help countiess victims of human trafficking in Virginia. Virginia Attorney General Ken Cuccinelli has just revealed plans to use the millions to help provide shellers and counseling to young women caught in prostitution rings. The money stems from a Medicaid fraud settlement, which secured millions of dollars for the Commonwealth. This money would give victims a place to escape the web of abuse.

Typically, it's vulnerable or troubled women and children who are lured into forced prostitution. However, boys have been victimized, as well. Sex trafficking doesn't just happen to immigrants coaxed into the U.S., with promises of a better life, either. These victims grow up in Virginia, and across the country, some right out of our local high schools.

Holly Smith now lives in Richmond. She was lured away by a predator at 14 years old, when she lived with her family in New Jersey.

talked to him on the phone every other night for about two weeks. He developed a relationship with me, a" friendship with me," said Smith of how the predator manipulated her.

Holly describes in her upcoming bock, Walking Prey, how that friendship quickly turned dark. She ran away with the man who played on her insecurities, in just hours, Holly was swept into a motel room filled with strange men. She was forced to sell her body.

"When I realized what these people expected me to do...

t had honestly thought it was my fault because I had chosen to run away," described Holly of the traumatizing experience.

Holly was eventually picked up by police, and brought home. She's been advocating against human trafficking

Cuccinelli is continuing the fight against sex and labor rings, in Virginia.

"The overwhelming proportion of what we see is gang-run sex trafficking. Girls (are) recruited out of our own schools, own neighborhoods...(Predators, gangs and pimps) make these girls available many times a night, a weekend," said Cuccinelli of what he calls "evil that's beyond describable."

The moneywould create shelters and support for emotionally and physically battered victims. Richmond's Gray Haven agency helps those who've suffered in sex or labor rings

"Right now, there's not one shelter in the state of Virginia that's specifically designed for victims of human trafficking," said Josh Bailey, co-founder of the agency.

"From the street, they need to have a place to go," urged Smith.
