(b)(1) EO 13526 § 1.4(c) ON EFFORTS TO CONTROL CRIMINAL AND TERRORIST GROUPS GEORGIA. HE ALSO TALKED ABOUT THE INVESTIGATION INTO AN ASSASSINATION ATTEMPT AGAINST PRESIDENT BUSH AND THE LEADER OF GEORGIA BY AN INDIVIDUAL WHO TOSSED A GRENADE DURING A RALLY ATTENDED BY A CROWD NUMBERING 130,000. GEORGIAN POLICE CONDUCTED A PHOTO ANALYSIS OF THE CROWD AND DISCOVERED A YOUNG MAN WITH SUNGLASSES WHO WORE A LEATHER COAT WITH A FUR COLLAR DESPITE THE OUTSIDE TEMPERATURE OF 30 DEGREES CENTIGRADE ON 10 MAY 2005. THIS INDIVIDUAL WAS IDENTIFIED AS VLADIMIR ((ARUTYUNIAN)) AND ARRESTED. HE DECLARED THAT HIS MOTIVE FOR THE ATTEMPTED ASSASSINATION WAS HIS HATRED OF PRESIDENT BUSH AND THE PRESIDENT OF GEORGIA.
