Contributions to the Nancy Pelosi Victory Fund will be allocated as follows: The first \$5,200 of each contribution from a person and the first \$10,000 from a multicandidate committee will be allocated to Nancy Pelosi for Congress. The first \$2,600/\$5,000 of a person's/multicandidate committee's contribution will be considered designated for the primary election; the second \$2,600/\$5,000 will be considered designated for the general election. The next \$5,000 of each contribution will be allocated to PAC to the Future. The next \$32,400 of each contribution from a person and the next \$15,000 of each contribution from a multicandidate committee will be allocated to the Democratic Congressional Campaign Committee, Inc. Any contributor may designate his or her contribution for a particular participant. The allocation formula above may change if any contributor makes a contribution that, when allocated, would exceed the amount that the contributor may lawfully give to any participant.
